

**SUBJECT**: Art on the TART Update

The 10<sup>th</sup> Street Trailhead project is moving along smoothly. Site design has been completed per Caitlin Early's presentation at the October meeting. TART is also in the process of applying for a MCACA Sparks and Starts grant (\$4,000 max) to be used towards unforeseen landscaping design costs and/or unexpected expenses from the art instillation and permitting. These funds wouldn't be used towards art line items, but rather the placemaking project as a whole.

The RFQ draft has been completed and reviewed by both Commissioners Kelto and Niemi. We are in the process of renewing our CaFÉ account and will have it up and running in time for the call to open December 1, pending RFQ approval by the board.

Both the site design and the RFQ can be found in the packet. RFQ verbiage expressed the Commission's desire for entries that are non-sculpture art pieces.

## **Project Intent**

The purpose of this RFQ is to select an individual artist to create, fabricate and install public art at the Tenth Street trailhead along the Boardman Lake Trail in Downtown Traverse City. The art installation will serve to enhance the trailhead (and trail experience) and its connection with the nearby Old Town Neighborhood. Part of TART's system non-motorized trail, the Tenth Street trailhead services the Boardman Lake Loop as it traverses around beautiful Boardman Lake.

## **Project Background & History**

For several years, TART Trails has been working diligently to complete the Boardman Lake Loop, a 6-mile non-motorized trail around Boardman Lake. This past year, construction began on the last section of trail to complete the loop, with construction targeted for completion in the fall of 2021.

The Traverse City Arts Commission has given their support to this project every step of the way and partnered with TART to assist in efforts to install public art at key trailheads along the trail. In doing so, this partnership will bring recreation and the arts together to enhance the trail experience and add to Traverse City's unique sense of place.

The art installation at the Tenth Street Trailhead will be part one of two such trailhead installations along the TART Trail. A second art installation is targeted for the Sixteenth Street Trailhead. It is a priority of both the Traverse City Arts Commission and TART to connect outdoor recreation with the arts.

## **Project Details**

The Traverse City Arts Commission is working with TART Trails, Inc. to install several art pieces at strategic locations along the Boardman Loop Trail, part of their "Art on the TART" program. The first location is slated for the Tenth Street Trailhead. TART Trails is working with INHABITECT (a local landscape company) to manage the design and installation of the landscaping. A preliminary site plan and INHABITECT's proposal are attached.

The Arts Commission and TART have dedicated \$20,000, toward the installation of art at the Tenth Street location. Non-sculpture pieces are highly encouraged, these can include: multisensory, multifunctional (ie furniture), and immersive works.



## **Contract Requirements**

The finalist shall enter into a contract with the City of Traverse City upon acceptance of proposal. Michigan law shall apply to the contract and agreement between artist and the City of Traverse City.

Title to and ownership of the artwork passes to the City of Traverse City upon written acceptance of and payment for the work.

Copyright belongs to and remains with the artist. The artist retains all rights under the Copyright Act of 1976 (17 USC Section 101) as the sole author of the work for the duration of the copyright. The duration of copyright in the United States is currently the life of the author plus seventy (70) years.

The City of Traverse City retains the right to reproduce the artwork in any and all forms, and will include credit to the artist and notice of copyright on all reproductions.

The Arts Commission recognizes some changes may occur during the process of creating the finished artwork. If, in the reasonable judgment and opinion of the Commission, the final artwork is materially different than the concept presented and accepted during the selection process, the Commission reserves the right to request revisions to, or recreation of the art. It is the responsibility of the artist to discuss with the Traverse City Arts Commission any changes during the creative process that could be considered materially different.

If three dimensional, the piece must be installed in a workmanlike manner with sufficient anchoring to prevent it from being removed, tipped, broken, or overturned. The artwork and installation will be completed so that the artwork does not create any known risk to the public. The commission will review the artist's proposed installation plans and may make recommendations to modify them to address safety concerns of the City of Traverse City.

The City of Traverse City and the Arts Commission reserve the right to relocate the artwork to a comparable downtown site at the direction of the City Commission, should future City projects necessitate a change.

The City of Traverse City requires that the selected artist carry Liability Insurance in the amount of \$2,000,000 (two million dollars) per incident during the production of the artwork, with an endorsement naming the City of Traverse City as additional insured.

The artist and the City of Traverse City shall and hereby agree to defend, indemnify, and hold harmless each other against any liability that arises out of the other Party's negligent or willful behavior.

Artists will be disqualified if they owe taxes to the City of Traverse City.

## **Eligibility**

The project is open to all qualified artists age 18 and over. Teams of artists are welcome to apply.

#### **Selection Process**

The project will follow the process and guide described in the Public Art Program Master Plan for Traverse City, available at traversecitymi.gov/artscommission.asp. The artist and final art will be selected by the Art Selection Panel and a recommendation will be made to the Arts Commission for final consideration.

The Arts Commission reserves the right to reopen our search if the right finalist/project is not found.

The call for entry process will include the following:

The Art Selection Panel reviews artists submittals and qualifications and develops a short-list with a maximum of (3) artists.

The selected artist(s) are invited to develop and submit a concept for the art piece and will be compensated to develop a drawing or maquette.

The Art Selection Panel selects its first choice artist and makes a recommendation to the Arts Commission. The Arts Commission Chairperson reviews the recommendation, completes an artist phone interview, background check, and speaks with the references provided by the artist.

## **Budget**

#### [SAMPLE BUDGET]

The artist fee is \$\_\_\_\_\_ (Sixteen Thousand Five Hundred Dollars) and includes all artist expenses for project completion including artist fees, materials, fabrication costs to develop the original art, documentation, transportation and shipping, and travel.

The total budget is \$20,000 (Twenty Thousand Dollars) which includes \$5,000 (Five Thousand Dollars) from the Public Arts Trust Fund. The total budget includes all expenses for the project including artist materials and fee, travel expenses and artist reimbursables, structural investigation or engineering if needed, permits, installation, sign plaque, and any events or artist forums.

#### **Maintenance**

The Arts Commission will work with the selected artist to identify specific maintenance requirements for the artwork. The maintenance plan will need to consider seasonal cleaning of the work. All maintenance on the artwork will be paid for with funds from the Public Arts Trust Fund. Landscape maintenance to be maintained and paid for by TART Trails. Ground maintenance such as lawn mowing to be done by City of Traverse City.

## **Project Descriptions**

### Parks (Non Bayfront)

#### Hannah Park (82)

Hannah Park is located at Union Street and stretches along 6th Street in Central Neighborhood. Crooked Tree Arts Center is located in the Carnegie Building next to Hannah Park. Park updates are currently planned for this Fiscal Year with irrigation added in the fall 2019 and the trail improvements planned for spring 2020.

#### **Hickory Hills (53)**

Hickory Hills recently received a major overhaul. The City continues to make improvements to Hickory Hills and is completing work on the nordic trails and new mountain bike trails. Opportunities for public art are endless at the 150+ acre park including art that could be incorporated into the new lodge or maintenance building.

### **Small Neighborhood Parks**

#### **Indian Woods Park (43)**

The Indian Woods Park will see updated play equipment, bike racks, picnic areas, ADA access through the park and other general improvements in FY 20-21. Funding for this park is confirmed from the City's Brownbridge funds and a DNR grant.

#### **Boon Street Park (46)**

Boon Street Park will see general improvements including a defined park entrance, reworked (possibly removed) parking, picnic area, and landscaping in FY 20-21. Boon Street Park is a small park in the Traverse Heights neighborhood that is on Boon Street, right at the City limits edge.

#### Jupiter Gardens (71)

Jupiter Gardens will see general improvements in FY 20-21. Jupiter Gardens is a City park located near Boyd and Rose Streets. The TART Trail runs along the south side of the park. The neighborhood has been discussing ideas since as early as 2014. Due to the proximity to the TART Trail, edible vegetation and a health focus have been discussed and a covered seating area.

#### **Urban Core**

#### **Eighth Street (81)**

The Eighth Street corridor recently received a major overhaul and with the reconstruction came the discussion of potential public art locations. Medians along the corridor near Wellington and Franklin Streets as well as an expanded right of way at the corner of Eighth and Woodmere, may all be opportunities.

#### **Mural Exhibition (80)**

An exhibition of one or more murals throughout the City on public or private (in the public realm) buildings.

#### Jay Smith Walkway (52)

The Jay Smith Walkway is located on the 100 block of E. Front Street between Pangeas and Kilwins. The walkway supports high pedestrian traffic, especially during days of the Sara Hardy Downtown Farmers Market. There has been discussion of utilizing the space for public art. Also, the fountain is in very bad shape and an opportunity may arise there as well.

#### Hardy Parking Garage/Public Restrooms (Edited) (29)

The Hardy Parking Deck is already home to public art sponsored by the Downtown Traverse City Association including murals at the E. Front Street entrance and the painted car hoods that hang in the staircase towers. The Larry Hardy bust was installed at the time of construction and is now in the Arts Commission's collection. The east facade of the deck is highly visible from Boardman and State Streets and rectangular shaped indentations exist in the brick. The indentations could provide locations for public art including murals painted on panels or sculptural murals. There is also opportunity in the small easement on the west side of the parking garage. Note; previous projects i.e. car hood installation resulted in a costly engineering analysis to ensure the structural integrity was not going to be compromised. Anything affixed to the parking garages would result in the same.

*Edited:* There is opportunity on the easement near the public restrooms.

#### Trail Network

#### Boardman Lake Trail/Art on the TART (105)

As you may recall, the Arts Commission is working with TART on a project targeting the two trailheads at 16th and 10th Street. Funding has already been approved for this portion of the project and is in the works.

The Boardman Lake Loop is scheduled for completion in 2020 and there will be opportunity to continue the previous planning efforts of "Art on the TART" along the Loop. Art on the TART is to focus on four elements; ecology, economy, history, and education.

#### For Future Consideration

#### **Urban Core**

#### **Rotary Square (Added)**

The DDA is in the planning stages of developing "Rotary Square," a civic square that will be in the downtown area. Property has yet to be secured to plan for the development of the project. Rotary Square will be a significant project for the City center and once in planning stages, due to some funding dollars secured, the project could take off in FY 21-22 or 22-23.

#### Sara Hardy Downtown Farmers Market (66)

The DDA was planning for reconstruction of the Sara Hardy Downtown Farmers Market and public art was incorporated into the plan. While the reconstruction is on hold, the DDA's Capital Improvement Plan has the project for 21-22

#### Bridge Art (49)

West Front, Park, Eighth, and Cass Street bridges are all scheduled for partial or complete reconstruction in the upcoming years. Eighth and West Front are scheduled to begin in 2020. During initial planning, it was encouraged to incorporate public art. However, the incorporation of public art was going to delay the permitting from the Army Corp. of Engineers and therefore was tabled. The opportunity still exists after construction.

#### **Bayfront Parks**

#### West End Beach (66)

West End Beach bath house, parking and beach area are scheduled to have reconstruction in FY 22-23

#### **Bryant Park (49)**

In FY 21-22, planned improvements to Bryant Park include updating the bath house and adding new pavilions.

#### Parks (Non Bayfront)

#### FishPass (70)

A project that is moving forward with the City of Traverse City near the Union Street Dam on the Boardman River. The plan is in place and the opportunity to place public art at the site is still available. However, after construction due to plan approvals already being submitted.

#### **American Legion Park (26)**

In FY 22-23, planned improvements to the American Legion Park include a new terrace wall and event space.

## Removed (These items were removed from the Prioritization List)

#### **East Front Street Banner Art**

The streetscape includes 28 foot tall light poles that can accommodate large banners on the outside of the poles. Currently, the City and DDA contract with Britten Banner to manage the existing banner program in Downtown. East Front Street's overhead light poles provides an opportunity to implement a large scale art installation that would make a high impact along a street that is struggling to find its identity.

Note; the DDA has a streetscape improvement project in their Capital Improvement Plan. The year of implementation is now looking to coincide with the reconstruction of the intersection of E. Front Street and Grandview Parkway and may not be until 23-24. The City is working with MDOT to confirm potential time frame. Also of note; the City does have a Banner Fund for these types of projects.

Reason for Removal: Scored very low on Prioritization Exercise and as mentioned above, there a Banner Fund with the City of Traverse City for this type of expenditure.

#### **Rotary Square Pop Up**

The DDA is in the planning stages of developing "Rotary Square," a civic square that will be in the downtown area. Similar to the #MyCivicSquare event that took place several years ago in Lot O, the pop up event can draw attention to the importance of a Civic Square. During the #MyCivicSquare event the Arts Commission hosted a public art project where parking spaces were designed with Chalk Art and the public voted on their favorite.

Reason for Removal: Based on the description that the Arts Commission previously reviewed in 2019, this item is an event and not a major Capital expenditure. I have added Rotary Square to our Prioritization list as a possible location for public art in the future. If there is a desire to host an event, then it should fall under a different line item in our budget.
