**Subject**: Budget Summary and Budget Amendment Consideration

As you are aware, the Arts Commission is poised to move forward with two remaining projects under the 2021/2022 budget year - the art installation at 16<sup>th</sup> Street (the second of the Art on the TART initiatives) and the Strategic Plan.

After reviewing the year-to-date budget (including all paid invoices to artists and contractors), if we move forward with the two projects, I calculate that we will be \$9,721.78 over the 2021/2022 budget. The attached budget sheet identifies the costs incurred to date for each project and the anticipated costs for the remaining two projects.

As you may recall, TART and the Arts Commission dedicated \$30,000 toward the two Art on the TART projects, with an understanding that costs for the two projects would be split roughly 50/50 (that is \$15,000 for the 10<sup>th</sup> Street Trailhead project and \$15,000 for the 16<sup>th</sup> Street project). As you can see on the spreadsheet (in orange), the costs for the 10<sup>th</sup> Street Trailhead project totaled \$17,595.82. The increased costs (above the \$15,000 threshold) were attributed to higher than anticipated costs for installation and signage. If the Arts Commission intends to stay within the \$30,000 threshold for the two projects, the remaining \$12,404.18 would be dedicated for the 16<sup>th</sup> Street installation (which would include artist fees, installation and signage).

The second remaining project is the Strategic Plan for \$12,000.

Additional costs incurred for this budget year included the extension for the Robert Sestok sculptures, the GIS intern (whose costs were split with the city), higher than anticipated costs for signage and additional funding for the strategic plan.

Based on the two remaining projects, I am suggesting the Arts Commission seek a budget amendment in the amount of \$12,000. This amount would include the \$9,721.78 needed to complete the two remaining projects as well as a 10%

contingency. The budget amendment would be deducted from the current fund balance, which sits at roughly \$119,800.

If approved, the budget amendment would be submitted to the DDA for their approval at their February 18<sup>th</sup> meeting and the City Commission at either their March 7<sup>th</sup> or March 21<sup>st</sup> meeting. The approval of the budget amendment will be needed prior to entering into a contract with Ms. Motil for the Strategic Plan.

#### **Recommended Motion**

That the Traverse City Arts Commission submit a request to the DDA Board of Directors and the City Commission for a budget amendment of \$12,000 for the 2021/2022 budget.

## **Project Intent**

The purpose of this RFQ is to select nine local artists to design a twenty-eight (30) digital images that will be placed on pole banners along West Front Street. The banners will serve to enhance the experience, aesthetic and sense-of-place of West Front Street. The theme of the banners is "fresh perspectives of downtown". Submissions should reflect different perspectives of Downtown Traverse City.

## **Project Background & History**

The banners along West Front Street were installed as part of a comprehensive streetscaping project in 2015. The design and color scheme for all 30 banners was universal. The banners are planned to be replaced in 2022. In cooperation with Britten Banner, the Arts Commission is using this opportunity to bring color and art into this highly visual streetscaping element. To be clear, the Arts Commission is excited for this banners to serve as "art", rather than the promotional/celebratory banners that are utilized in other parts of downtown.

## **Project Details**

The Traverse City Arts Commission is working with Britton Banner to install 30 new banners in nine different "sets" along West Front Street. The Arts Commission is seeking at least four (4) unique banner designs from nine local artists under the theme of "a fresh perspectives of downtown". Submissions should reflect different perspectives of Downtown Traverse City. Any type of painting (e.g., abstract, impressionism, etc.) photography and/or graphic art may be submitted. Final designs must be compatible with fabrication processes established by Britten Banner Inc., who will be printing and installing the banners. Banner sets include:

Set One: 2 single-banners (south side) Front Street and Division
Set Two: 3 single-banners (north side) Front Street and Maple
Set Three: 3 single-banners (south side) Front Street and Maple

Set Four: 2 double-banners (north side)
Set Five: 2 double-banners (south side)
Set Six: 2 double-banners (north side)
Front Street (in front of the GT Pie Company)
Front Street (in front of the Fogarellis)

Set Seven: 2 double-banners (south side) Front Street (in front of Walter and Hemmings)

Set Eight: 3 single-banners (north side) Front Street and Wadsworth
Set Nine: 3 single-banners (south side) Front Street and Hall Street

All banners are two-sided. The size of each banner is 24" x 48". Given the arrangement (or "set") of banners along the corridor, some artists will have four banners printed, some will have three banners printed and some will have two banners printed. We ask that each artist submit four different designs. The Arts Commission will select two or three of the best designs (from the four submitted), for those areas along the corridor with the corresponding number of banners. The Arts Commission will also select the location(s) of each banner along the corridor.

## **Contract Requirements**

The finalist shall enter into a contract with the City of Traverse City upon acceptance of a proposal. Michigan law shall apply to the contract and agreement between the artist and the City of Traverse City.

Title to and ownership of the artwork passes to the City of Traverse City upon written acceptance of and payment for the work.

Copyright belongs to and remains with the artist. The artist retains all rights under the Copyright Act of 1976 (17 USC Section 101) as the sole author of the work for the duration of the copyright. The duration of copyright in the United States is currently the life of the author plus seventy (70) years.

The City of Traverse City retains the right to reproduce the artwork in any and all forms, and will include credit to the artist and notice of copyright on all reproductions.

The Arts Commission recognizes some changes may occur during the process of creating the finished artwork. If, in the reasonable judgment and opinion of the Arts Commission, the final artwork is materially different than the concept presented and accepted during the selection process, the Commission reserves the right to request revisions to, or recreation of the art. It is the responsibility of the artist to discuss with the Traverse City Arts Commission any changes during the creative process that could be considered materially different.

The City of Traverse City and the Arts Commission reserve the right to relocate the artwork to a comparable site at the direction of the City Commission, should future City projects necessitate a change.

The artist and the City of Traverse City shall and hereby agree to defend, indemnify, and hold harmless each other against any liability that arises out of the other Party's negligent or willful behavior.

Artists will be disqualified if they owe taxes to the City of Traverse City.

## **Eligibility**

The project is open to all qualified artists age 18 and over living or working in Traverse City.

### **Selection Process**

The project will follow the process and guide described in the Public Art Program Master Plan for Traverse City, available at traversecitymi.gov/artscommission.asp. The artist and final art will be selected by the Art Selection Panel and a recommendation will be made to the Arts Commission for final consideration.

The Arts Commission reserves the right to reopen our search if the right finalist/project is not found.

The call for entry process will include the following:

- The Art Selection Panel reviews artists submittals and qualifications and develops a preferred-list of (3) artists.
- The selected artist(s) are invited to develop and submit a minimum of four concepts for the project area.
- The Art Selection Panel selects the final artists and makes a recommendation to the Arts Commission.
- · Arts Commission approves the artist and the design.

#### **Timeline**

All dates but the Artists Qualifications Deadline are subject to change:

February 16, 2022 Call for entry approved by Arts Commission.
 February 17, 2022 Call opens.
 March 18, 2022 Call closes and artists qualifications due.

March 22, 2022 Art Selection Panel review artists qualifications and selects finalists.

April 8, 2022 Finalists submit concept art.
 April 12, 2022 Art Selection Panel selects artists.

April 20, 2022 Artist and artwork considered by Arts Commission.
 April - May 2022 Artists work with Britton Banner to fabricate art.

• May – June 2022 Banners hung.

## **How to Apply**

Artists who wish to be considered for this project must prepare and submit the following materials online or in hard copy form. Information on where to apply and submit can be found on the first page of this RFQ packet.

#### Required materials include:

- 1. Letter of interest one page only explaining interest in the project
- Current resume detailing past or current commissions and public installations of work (if a team application, include resumes of all members), and including artist name, gallery representation (if any), address, phone, and email.
- 3. Images examples of representative work history in the past five years, not exceeding 16 high resolution images, 3 videos, and 1 audio, with emphasis on recent work.
- 4. Image annotation artwork title, date, medium, size, location as appropriate, and the commission budget for the work, if applicable.
- 5. References list of three professional references with knowledge of the artist's work and working methods. This list must include complete addresses and phone numbers for the reference.
- 6. Optional artists may submit up to three items of support materials (i.e. reviews, articles about their work etc.)

  - b. A persistent and knowing violation of the Michigan Consumer Protection Act.
  - c. Willful or persistent violations of the Michigan Occupational Health and Safety Act.
  - d. A violation of federal, local, or state civil rights, equal rights, or non-discrimination laws, rules, or regulations.
  - Repeated or flagrant violations of laws related to the payment of wages and fringe benefits.
- 6. the loss of a license or the right to do business or practice a profession, the loss or suspension of which indicates dishonesty, a lack of integrity, or a failure or refusal to perform in accordance with the ethical standards of the business or profession in question.

## **Project Intent**

The purpose of this RFQ is to select an individual artist to create, fabricate and install public art along the Boardman Lake Trail at Sixteenth Street in Traverse City. The art installation will serve to enhance the experience of the trail user and compliment an emerging trail node and the surrounding area, which includes an expansive overlook of Boardman Lake. Part of TART's network of non-motorized trails, the area around Sixteenth Street provides direct access to the Boardman Lake Loop as it traverses around beautiful Boardman Lake.

## **Project Background & History**

For several years, TART Trails has been diligently working to complete the Boardman Lake Loop, a 6-mile non-motorized trail around Boardman Lake. This past year, construction began on the last section of trail to complete the loop, with construction targeted for completion in the spring of 2022.

The Traverse City Arts Commission has given their support to this project every step of the way and partnered with TART to assist in efforts to install public art at key nodes and trailheads along the trail. In doing so, this partnership will bring recreation and the arts together to enhance the trail experience and add to Traverse City's unique sense of place. It is a priority of both the Traverse City Arts Commission and TART to connect outdoor recreation with the arts.

The art installation along Sixteenth Street will be second of two art installations along the Boardman Lake Trail in the past twelve months. The first art installation was erected in the fall of 2021 at the Tenth Street Trailhead.

## **Project Details**

The Traverse City Arts Commission is working with TART Trails, Inc. to install several art pieces at strategic locations along the Boardman Loop Trail as part of their "Art on the TART" program. The next location is at a trail-node along Sixteenth Street. TART Trails is working with Team Elmer's (a local engineering and construction company) to manage the design and installation of the trail-node area. A preliminary site plan of the area can be found in Attachment A.

The Arts Commission and TART have dedicated \$12,400, toward the installation of art at the Sixteenth Street location. There are no parameters or theme limitations for this art installation. Creativity is key. Art that incorporates a dual purpose (e.g., bench, bike rack) is also welcomed but not required.

## Location

The project area is located along Sixteenth Street, overlooking Boardman Lake. The intended space for the art installation is a roughly 30' by 13' oblique shape. However, artists are encouraged to consider a creative art installation that incorporates structure(s) or artistic elements that blend into the surrounding landscape or trail (in addition to the oblique shape) if warranted. These elements may or may not be connected to the oblique space identified below. Any combination of elements that are not physically connected must share the theme of the overall art installation. That is, even if the installation includes several "pieces" it is considered one art installation. A map and image of the project area is included below.

## **Contract Requirements**

The finalist shall enter into a contract with the City of Traverse City upon acceptance of a proposal. Michigan law shall apply to the contract and agreement between the artist and the City of Traverse City.

Title to and ownership of the artwork passes to the City of Traverse City upon written acceptance of and payment for the work.

Copyright belongs to and remains with the artist. The artist retains all rights under the Copyright Act of 1976 (17 USC Section 101) as the sole author of the work for the duration of the copyright. The duration of copyright in the United States is currently the life of the author plus seventy (70) years.

The City of Traverse City retains the right to reproduce the artwork in any and all forms, and will include credit to the artist and notice of copyright on all reproductions.

The Arts Commission recognizes some changes may occur during the process of creating the finished artwork. If, in the reasonable judgment and opinion of the Arts Commission, the final artwork is materially different than the concept presented and accepted during the selection process, the Commission reserves the right to request revisions to, or recreation of the art. It is the responsibility of the artist to discuss with the Traverse City Arts Commission any changes during the creative process that could be considered materially different.

If three dimensional, the piece must be installed in a workmanlike manner with sufficient anchoring to prevent it from being removed, tipped, broken, or overturned. The artwork and installation will be completed so that the artwork does not create any known risk to the public. The commission will review the artist's proposed installation plans and may make recommendations to modify them to address safety concerns of the City of Traverse City.

The City of Traverse City and the Arts Commission reserve the right to relocate the artwork to a comparable site at the direction of the City Commission, should future City projects necessitate a change.

The City of Traverse City requires that the selected artist carry Liability Insurance in the amount of \$2,000,000 (two million dollars) per incident during the production of the artwork, with an endorsement naming the City of Traverse City as additional insured.

The artist and the City of Traverse City shall and hereby agree to defend, indemnify, and hold harmless each other against any liability that arises out of the other Party's negligent or willful behavior.

Artists will be disqualified if they owe taxes to the City of Traverse City.

# Eligibility

The project is open to all qualified artists age 18 and over. Teams of artists are welcome to apply.

#### **Selection Process**

The project will follow the process and guide described in the Public Art Program Master Plan for Traverse City, available at traversecitymi.gov/artscommission.asp. The artist and final art will be selected by the Art Selection Panel and a recommendation will be made to the Arts Commission for final consideration.

The Arts Commission reserves the right to reopen our search if the right finalist/project is not found.

The call for entry process will include the following:

- The Art Selection Panel reviews artists submittals and qualifications and develops a preferred-list with a maximum of (3) artists.
- Each selected artist will be required to conduct a site-visit to the project location.
- The selected artist(s) are invited to develop and submit a concept for the project area.
- The Art Selection Panel selects the final artist and makes a recommendation to the Arts Commission.
- The Director reviews the recommendation, completes an artist phone interview and speaks with references provided by the artist.
- Arts Commission approves the artist and art installation.

# **Budget**

The total budget is \$12,400 (Twelve Thousand, Four-Hundred Dollars) and includes all artist expenses for project completion including artist fees, materials, fabrication costs to develop the original art, documentation, transportation and shipping, and travel. Also included in the total project budget are expenses for structural investigation or engineering if needed, permits, installation, and a sign plaque. The artist should consider the total cost (including installation) of their project when determining the scope, size and type of art submitted.

### Maintenance

The Arts Commission will work with the selected artist to identify specific maintenance requirements for the artwork. The maintenance plan will need to consider seasonal cleaning of the work. All maintenance on the artwork will be paid for with funds from the Public Arts Trust Fund. Landscape maintenance to be maintained and paid for by TART Trails. Ground maintenance such as lawn mowing to be done by City of Traverse City.

Artists who wish to be considered for this project must prepare and submit the following materials online or in hard copy form. Information on where to apply and submit can be found on the first page of this RFQ packet.

Required materials include:

- 1. Letter of interest one page only explaining interest in the project
- Current resume detailing past or current commissions and public installations of work
  (if a team application, include resumes of all members), and including artist name, gallery

- 3. Images examples of representative work history in the past five years, not exceeding 16 high resolution images, 3 videos, and 1 audio, with emphasis on recent work.

As Up North Pride's large celebration moves to fall this year, we have been working on ways to celebrate community during other times of the year. This summer, Up North Pride is hoping to have our successful outdoor art exhibits, in partnership with BoxPop, return for all of Pride Month. This June, Up North Pride will install three new art exhibits in shipping containers across Northern Michigan. Each display will offer space for artists from the 2SLGBTQIA+ and BIPOC communities to explore the title theme of "Unconditional". Each installation will invite the public to explore this theme and celebrate together. The installations will be open to the public June 1 through June 30, 2022.

Up North Pride is asking the Arts Commission to help us (1) confirm a family-friendly location within the City that would be a good location for this exhibit and (2) help promote this event and call for artists. Hosting locations are responsible for the following:

- Alerting Up North Pride of any vandalism/required maintenance of the piece
  - Opening it up at the beginning of every work day and locking it up at the end of the work day
  - This would all be within the standard operating hours of the business
- Promoting on social media
- Assist in planning Up North Pride with an event to take place a weekend in June

Attached, please find the Project Proposal/Call for Artists for your review. We are also looking for sponsorship to pay for our artists, if the Arts Commission is interested in supporting in that capacity as well.



#### "Unconditional" An Immersive Art Installation

Completely, thoroughly, bodaciously, unequivocally, wholeheartedly, subject to no conditions. Unconditional. Oftentimes, the word unconditional is immediately linked with the word love and unintentionally assigned conditions by which it exists in this world. If we are able to give conditions to a word, we are definitely able to assign conditions to human emotions and behavior that we pass on to others as we move through the world.

Unconditional love does not necessarily mean unconditional acceptance. Unconditional acceptance does not necessarily mean unconditional support. As you explore and experience each of these installations, we ask that you identify areas of your own life where conditions that have been put in place can be removed. Do you love someone in your life only when they are presenting a certain way? Do you support someone in your life only when they do things that you deem "good and honorable"?

Everyone deserves to feel held and loved and accepted and seen as they are, not only as we want them to be. The conditions we put on ourselves and on others around us are born out of fear. We have asked three artists to examine their relationship with the word unconditional, with things they have put conditions on or conditions that have been placed on them throughout their life, and to use their art as a representation of that understanding.

We ask that as you experience each of the installations that you come to them unconditionally, with an open mind and heart. Please tap into your own understanding of where you place conditions in your life and challenge yourself to remove some of those conditions to experience or give someone else the experience of feeling love, support & acceptance without strings attached.

## **Project Summary**

For the month of June, Up North Pride will rent a minimum of three shipping containers that will be placed across Northern Michigan. Each location will provide a safe, accessible art exhibit in the theme of "Unconditional". An example of the Up North Pride exhibits from 2021 can be found here:



## Shipping Container Maintenance

Hosting locations will hopefully see a large influx of visitors during the month of June for the installation. Up North Pride would also like to host at least one pop-up event at the hosting location (one per week) to highlight the location and the art piece.

- Opening it up at the beginning of every work day and locking it up at the end of the work day

  - This would include setting out signage and sanitizing stations at each location when opening

#### **Artist Information**

Artists will be provided a \$2000 stipend from Up North Pride that will include their material costs for the project. A \$100 traveling allowance is provided as well. Housing will be provided by Up North Pride if it is needed for the install. Installation will be taking place the week of May 23 - 29.
