

Subject: Project Updates

#### Art on the TART - 16th Street Installation

Thinking ahead to the spring, we need to discuss future landscaping needs and responsibilities around the Teicher sculpture. This may include additional collaboration with TART.

#### Revolving Art – Mr. Petrokovitz

The City Commission approved the contract extension with Mr. Petrokovitz at their January 3<sup>rd</sup> meeting. Working with the City Attorney, I have sent the contract extension to Mr. Petrokovitz for his signature.

In addition, a subcommittee consisting of Commissioners Early and Niemi are planning to meet later this month to discuss a policy for rotating art exhibits.

#### **Paint-it-Forward Grant Program**

I am still waiting to meet with the City Attorney to discuss the administration of the *Paint it Forward* Program in January. The City Attorney mentioned that the Arts Commission cannot provide grants for operational costs.

#### **Banner Initiative**

One student from the Children's House developed art for a banner, but I am awaiting its digital delivery. With that, we have just a handful of art for the banners. We'll need to discuss and finalize our next step/approach.

#### **Park Initiative**

I talked briefly with the Parks Department about the mural concept at Bryant Park and we are planning to meet to go over schematic needs and building dimensions.

#### Wishing Tree

As I mentioned, I am working with the City Attorney to square away the easement for the area around the wishing tree. This art piece was a collaboration between the Arts Commission and Up North Pride and Lound and Proud. The painted ceramic "wishing leaves" are no longer hanging from the tree. The Arts Commission will need to discuss how this former project should move forward (i.e., another round of wishing leaves).



#### **Arts Commission Website**

City staff has indicated that the Arts Commission website should not be bundled up with their other websites and that on-going maintenance of the site will be the responsibility of the DDA. I know a handful of Commissioners agreed to review the website (for updated content). I will be meeting with internal DDA staff to assign updated roles and responsibilities.

#### **Mural Festival**

I am working to schedule a second meeting with the Leadership Team, which will also include a handful of other organizations that were submitted by members of the Leadership Team.



Subject: New Business

The following items were discussed at previous meetings (without resolution) and require additional discussion

#### **Perry Hannah Statue**

In 2020, the Arts Commission discussed revising the language on the Perry Hannah Statue. After several attempts to consider and draft revisions of the text, the Arts Commission decided to reach out to the Grand Traverse Band for additional discussion. After several months, we received a suggested revision of the text from the Elders Council of the Grand Traverse Band (see below).

I think the Arts Commission should review the draft language and discuss its possible application. The Arts Commission may also choose to explore the idea of adding or commissioning an additional marker using portions of this text. Based on our discussion, DDA staff would reach out to the individual donor of the statue/plaque. Just as a reminder, the new plaque would be purchased by the Arts Commission.

#### **Revised Text**

In July of 1851, at just 26 years of age, Perry Hannah, President of Chicago's Hannah, Lay & Company, sailed into the Grand Traverse Bay wilderness, for the very first time in search of timber to support his company's lumber needs during America's gilded age.

For the sum of \$4,500, Mr. Hannah purchased slightly more than 200 acres of heavily forested bay shore property that straddled what is now known as the Boardman river River and extended to Boardman lake-Lake. This was the raw-beginnings of a future great change.

Mr. Hannah came for the timber and remained for the rest of his life, serving as the city's first mayor and one term in the state legislature while constantly working to adjust altering the local economy to keep it alive. For more than 50 years he was respected by his employees and business associates[?], and their lives and building—helping to build a great community while andleaving extraordinary gifts of architecture and public land for the enjoyment of future generations. Virtually everything we see, touch, feel and sense about Traverse City today can be traced directly back to



founding father Perry Hannah. Much of Traverse City's current form can be traced to Perry Hannah's vision. His most readily recognized gift is his retirement home, located just a few steps west at 305 west sixth street West Sixth Street, a valued memory asset that speaks clearly to his legacy.

The land Hannah claimed for the construction of Traverse City had long been part of Kitchi Wiikwedong, the homeland of Odawa and Ojibway Anishinaabek. Made to conform to new definitions of property ownership and rights, the local Anishinaabek were increasingly forced with each federal treaty to change or abandon traditional ways of life and sacred practices and places, including those along the Ottaway (later Boardman) River and throughout the area that quickly became Traverse City. Nonetheless, according to English-language histories, the Anishinaabek were accommodating and generous, contributing to the success and prosperity of the very industries, town, and people, including Perry Hannah himself, so radically altering their lives and home.

#### Art on the TART

As you might be aware, TART Trail, in cooperation with the DDA and City of Traverse City recently kicked off a design/engineering process to expand (widen) the TART Trail along the bay. The trail extension would extend from Division to Peninsula Drive. At our first team meeting, we discussed the opportunity for additional trail amenities, including art. I only bring this up, as the Arts Commission might want to consider another art installation along this trail section if the opportunity arises.
