Attached are the budgets for TIF 97 and Old Town, along with the State annual report was submitted. We are on track for all the capital improvements for the 20/21 budget (minus the bridges). I have also worked with the auditors on our fiscal year ending 6/30/2020 which was completed last week. I anticipate having the audit to you in February and presented in February or March to the DDA Board.

We will also be presenting the parking budget to the Finance Committee as the Committee of the DDA responsible for all finances under DDA. I will also in addition be working with the City Treasurer's Office relating to the liabilities and equities.

To begin building from our meeting last month, Chair Hardy and I discussed how to work to complete a strategic planning session when the Board can meet together (possibly June 2021). The Finance Committee will need to work on scenarios to present to the full Board.

The Finance Committee and Governance Committee, along with our new legal counsel, will work together to have a successful strategic planning discussion.

Neighborhood Enterprise Zone (NEZ): As reported previously, an NEZ is being looked into for the new development at 124 West Front and 309 West Front. Redevelopment will be a mixed-use with first floor commercial and rental apartments above --- with the rental units being year-round living units. I will provide an overview of the NEZ to the Committee on Monday.
