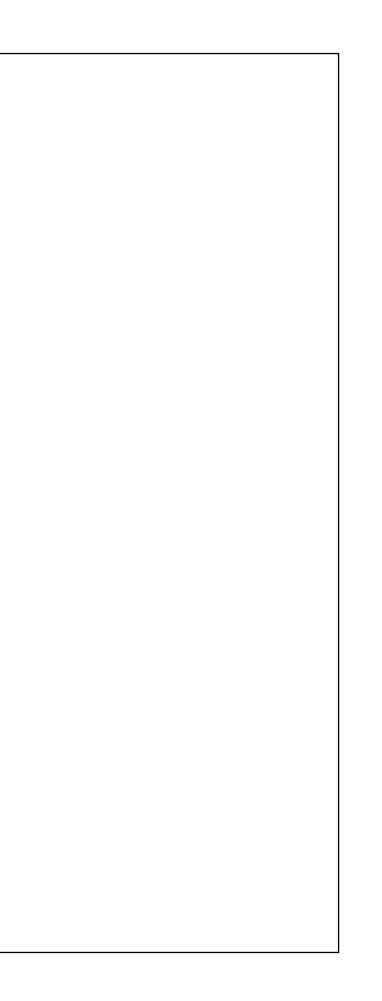

Rotating Art Exhibit Zone Request for Proposals

After we received no response from our RFP for the Rotating Exhibit Zone, Commission members worked to make inquiries about potential art/artists. Please be sure to come prepared to discuss opportunities for this project if you have made progress.

North Boardman Creative Initiative

Commissioner Early developed a draft project narrative for the North Boardman Creative Initiative (see attached). I'd like to review the document with the entire Commission.

Artwork Donation & Gift Request Forms

Following up on our discussion and approval of the "cairns" project submitted by Debra Graetz, I presented the concept to the city's "design team" (a weekly meeting with all department heads). I received approval for the concept, but a request for additional information related to the structural components of the project. I have reached out to Dr. Graetz to secure additional information.

Mural Festival

Commissioners Early, Amundsen and Neimi and I met with the NOBO board to discuss the mural festival and we received positive feedback. I have attached a working scope of the festival, so we understand the elements of the project. I will bring a preliminary project cost-sheet and description to the meeting.

Bayfront TART Trail Bench RFP

I have attached the draft RFP for the artistic benches along the Bayfront TART Trail. There are a few items we need to discuss, but I wanted to include the preliminary draft.

North Boardman Creative Initiative Project Narrative

EXECUTIVE SUMMARY

The 8th Street Creative District project aims to contribute to the vitality of the Grand Traverse region through artful placemaking opportunities that build on the community's cultural resources. The designation of a Creative District will elevate community values, stimulate community dialogue between people of all ages and abilities, inspire the mind and senses by creating an unexpected aesthetic experience, and enliven the appearance and appeal of this well-traveled community. People of all ages will gather as they enjoy this creative district, the businesses and establishments among it, and their contribution to the rich texture of the fabric that is the story of our time, our place, and our lives.

PROJECT PARTNERS

ORGANIZATIONAL OVERVIEW

TART Trails and the Traverse City Arts Commission, in cooperation with the City of Traverse City, strategically place art installations around the Boardman Lake Loop, both within and outside of the City limits. It is a priority of both the Traverse City Arts Commission and TART Trails to connect outdoor recreation with the arts, while supporting Michigan-based artists. There are currently seven art installations on view between Oryana 10th Street and Medalie Park.

Following the opening of the Boardman Lake Loop and the overwhelmingly positive community feedback from the art installations facilitated by TART Trails and the Traverse City Arts Commission, project partners have identified the 8th Street district as a priority to continue placemaking through public art. The results of the North Boardman Lake District Healthy 8th Street study further identify the need for a creative district to aid in placemaking, pedestrian accessibility, and visual signals of community goals and values.

- Sculptural elements marking "gateway" entrances to North Boardman district including on 8th Street at Lake Avenue, 8th Street and Barlow/Woodmere, and the confluence of Franklin Street and the Boardman Lake Loop
- Cairn Sculpture at Railroad and 8th Street
- Art installations that aid in ease of multi-modal transportation
- Sculptural bike racks placed incrementally along the 8th Street cycle track
- 5+ murals reflective of the surrounding community*

Project Intent

The purpose of this RFQ is to select an artist(s) to create, fabricate and help install two artistic public benches along the TART Bayfront Trail, part of a comprehensive effort to extend and expand the existing TATY Bayfront along Grandview Parkway. The artistic benches will serve to enhance the experience of the trail user as well compliment and add interest to a busy and popular trail corridor. The artistic benches will also serve to advance public art in Traverse City and help enrich the cultural and aesthetic quality of life in Traverse City. Practically, the two artistic benches will serve as a respite for trail users. Therefore, the final design of the benches must be fabricated in such a manner to allow for heavy use and/or activities and be designed in such as way that denotes the practical use as a bench.


Project Background & History

In 2022, the City of Traverse City, the Traverse City Downtown Development Authority (DDA) and TART Trails, Inc. initiated efforts to conduct design and engineering services for an extension and expansion (i.e., widening) of the TART Bayfront Trail along Grandview Parkway, between Division and the Senior Center (the scope of work now covers the expanse between Division and Eastern Avenue). This effort was spurred by a desire to improve and enhance non-motorized infrastructure along the corridor at the same time, and in conjunction with MDOT efforts to reconstruct Grandview Parkway (slated to begin in March 2024 through November 2024). In October 2023, TART Trails was awarded a RAP grant from MEDC for construction of a portion of the trail extension. These grant dollars were matched by additional financial contributions from the City, DDA and TART. With the final design in place, the RFP for construction was released in February. While waiting for bid submissions, the Arts Commission is releasing this RFP for two benches that will be included in the final design and construction of the trail extension. The timing of construction is still unknown at this time. However, it is the desire of the Arts Commission to work with the selected artist(s) to design and fabricate the benches ahead of time to they are ready to be installed when ready.

Project Details

There will be several uniform benches placed along the trail entension (see image right). However, the Arts Commission and the project partners are excitied to inlcude two artistic benches at strategic locations on the trail corridor.

One bench will be located near the new senior center building. The second bench will be located near the point where the trail diverges to traverse under the Murchie Bridge (see maps next page). The bench will be mounted and secured on 4-inches of concrete pavement.

The Arts Commission has dedicated **\$--** toward the fabrication and installation of each bench. There are no parameters or theme limitations for this art installation. Creativity is key. However, each bench must serve the practical purposes of providing respite. Due to uncertainty around the timing of construction, there is no firm deadline for installation at this time. However, the Arts Commission will be working closely with the artist as the project moves forward to ensure each bench is fabricated in time for installation, when needed. The artist should be prepared to assist in the installation of each bench, in coordination with the project contractor and/or city staff.

Contract Requirements

The finalist shall enter into a contract with the City of Traverse City upon acceptance of a proposal. Michigan law shall apply to the contract and agreement between the artist and the City of Traverse City.

Copyright belongs to and remains with the artist. The artist retains all rights under the Copyright Act of 1976 (17 USC Section 101) as the sole author of the work for the duration of the copyright. The duration of copyright in the United States is currently the life of the author plus seventy (70) years.

The City of Traverse City retains the right to reproduce the artwork in any and all forms, and will include credit to the artist and notice of copyright on all reproductions.

The Arts Commission recognizes some changes may occur during the process of creating the finished artwork. If, in the reasonable judgment and opinion of the Arts Commission, the final artwork is materially different than the concept presented and accepted during the selection process, the Commission reserves the right to request revisions to, or recreation of the art. It is the responsibility of the artist to discuss with the Traverse City Arts Commission any changes during the creative process that could be considered materially different.

If three dimensional, the piece must be installed in a workmanlike manner with sufficient anchoring to the concrete pads to prevent it from being removed, tipped, broken, or overturned. The artwork and installation will be completed so that the artwork does not create any known risk to the public. The commission will review the artist's proposed installation plans and may make recommendations to modify them to address safety and maintenance concerns of the City of Traverse City.

The City of Traverse City and the Arts Commission reserve the right to relocate the artwork to a comparable site at the direction of the City Commission, should future City projects necessitate a change.

The City of Traverse City requires that the selected artist carry Liability Insurance in the amount of \$2,000,000 (two million dollars) per incident during the production of the artwork, with an endorsement naming the City of Traverse City as additional insured.

The artist and the City of Traverse City shall and hereby agree to defend, indemnify, and hold harmless each other against any liability that arises out of the other Party's negligent or willful behavior.

Artists will be disqualified if they owe taxes to the City of Traverse City.

Eligibility

The project is open to all qualified artists age 18 and over. Teams of artists are welcome to apply.

Selection Process

The artist and final art will be selected by the Arts Commission. The Arts Commission reserves the right to reopen our search if the right finalist/project is not found.

The call for entry process will include the following:

- The Art Commission reviews artists submittals and qualifications and develops a preferred-list with a maximum of (3) artists.
- Each selected artist will be required to conduct a site-visit to the project location.
- The selected artist(s) are invited to develop and submit a concept for the project area.
- The Arts Commission Liaison reviews the recommendation, completes an artist phone interview and speaks with references provided by the artist.
- Arts Commission approves the artist and art installation.

Budget

The total budget is **\$---** which includes <u>all</u> artist expenses for project completion including artist fees, materials, fabrication costs to develop the original art, documentation, transportation and shipping, and travel. Also included in the total project budget are expenses for structural investigation or engineering if needed, permits and installation. The artist should consider the total cost (including installation) of their project when determining the scope, size and type of art submitted.

Maintenance

The Arts Commission will work with the selected artist to identify specific maintenance requirements for the artwork. A maintenance plan will need to be submitted by the artist and should consider seasonal cleaning of the work.

How to Apply

Artists who wish to be considered for this project must prepare and submit the following materials in hard copy form. Information on where to apply and submit can be found on the first page of this RFQ packet.

Required materials include:

- 1. Letter of interest one page only explaining interest in the project
- 2. Current resume detailing past or current commissions and public installations of work (if a team application, include resumes of all members), and including artist name, gallery representation (if any), address, phone, and email.
- 3. Images examples of representative work history in the past five years, not exceeding 16 high resolution images, 3 videos, and 1 audio, with emphasis on recent work.
- 4. Image annotation artwork title, date, medium, size, location as appropriate, and the commission budget for the work, if applicable.
- 5. References list of three professional references with knowledge of the artist's work and working methods. This list must include complete addresses and phone numbers for the reference.
- 6. Optional artists may submit up to three items of support materials (i.e., reviews, articles about their work etc.)
- 7. A Maintenance Plan for the duration of the exhibit.

 - d. A violation of federal, local, or state civil rights, equal rights, or non-discrimination laws, rules, or regulations.
 - e. Repeated or flagrant violations of laws related to the payment of wages and fringe benefits.
- 6. the loss of a license or the right to do business or practice a profession, the loss or suspension of which indicates dishonesty, a lack of integrity, or a failure or refusal to perform in accordance with the ethical standards of the business or profession in question.
